With regard to Question 1, who is the controlling shareholder?

**Company’s response:**

The controlling shareholder is Olander Ltd (“**Olander**”), which is owned by Dato Sri Yap Teiong Choon and Phan Foo Beam.

**SGX-ST’s Question 3:**

What is the ‘certain amounts owing by the Vendor to the Assignee’ about?

**Company’s response:**

Based on the Company’s understanding and representations by the management of RC, the certain amounts owing by RC to Amanland arose from past transactions involving the assignments of receivables and payables outstanding amongst the Vendor, Assignee and Olander.

**SGX-ST’s Question 4:**

The full amount owing by the Vendor to the Assignee is S\$7.5 million?

**Company’s response:**

The full amount owed by RC to Amanland is USD5,538,998.12.
